Sponsored Reserves – Individuals who fulfil the required training obligations are entitled to receive half of the appropriate rate of full annual Operational Training Supplement (OTS), plus a further proportion of the OTS calculated based on the Volunteer Reserves Bounty rates and the number of Man Training Days (MTDs).

Where 5th and subsequent years bounty is not shown personnel should receive the 3rd and 4th year payment.

ARMY ONLY

Full-time and Part-time reservists are not eligible for Training Bounties by virtue of the nature of their duties.
